I have to make your attent on that Veterinary Pharmacist training courses are running by some unauthorized institutions and large amount of money are being received from inr ocence unemployed youngsters. In this some are like as Sahid Baba Deep Singh Educational and Welfare Society Institute is running this course at Khanna Malout, Sahkot, TranTaran, Bathinda and Fazialka. According to the received information these institutes are running training courses in one single room by some unqualified staff. They have no basic Infrastructure, Laboratories, Computers, Vet. Hospitals for running these courses and these are not recognized by Government of Punjab. The two year Veterinary Pharmacist course run by Govt. Polytechnic, Patiala in Punjab, in which complete theory, practical and field training facilities are provided. This only Polytechnic Institute is recognized for getting the job in Punjab.

In this situation I feel that at where these institutes are running the training courses illegally by cheating. On the other side the Veterinary Pharmacists trained by these institutes have no hope to get a job in department. So that it is decided that by taking the legal action, the cases must be registered against these institutes.
