In this writ petition, following prayer has been made
by the petitioners :-

"a) to issue an appropriate writ, order or direction
to the respondents no. 1 & 2 to consider the
petitioners, as eligible for the post of Femal Health
Worker.

b) to issue an appropriate writ, order or direction
to the respondent no.1 & 2 to quash and set aside
the condition no.2, i.e. Registration with Rajasthan
Nursing Council in B Grade nurse of the
advertisement dated 26.02.2013.

c) to issue an appropriate writ, order or direction
to the respondent no.3 to Register the name of

Petitioners, in the Register of Registrar, Rajasthan Nursing Council i.e. Respondent No.3;

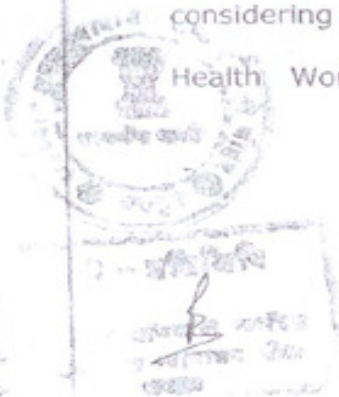
d) to issue an appropriate writ, order or direction quashing the Advertisement No. Nursing / (Direct Recruitment-2013) / 2013 / 23 dated 26.02.2013 (Annexure-1) vide which a condition has been imposed that for recruitment to the post of Female Health Worker only those candidates who have been registered with the Rajasthan Nursing Council i.e. Respondent No.3, will be considered eligible;

e) issue an appropriate writ, direction or order directing the respondent 1 & 2 for declaring that all diplomas being awarded for Multipurpose Health Workers from registered institutions from other States will also be considered eligible;

f) That the Hon'ble High Court may kindly direct the Respondents to consider the candidature of the petitioner for the post of Health Worker Female'.

g) That Hon'ble Court may kindly further direct the Respondents to give the appointment to the petitioners on the post of 'Health Worker Female' if petitioners fall in merit.

Although the petitioners are seeking direction for considering their case for appointment on the post of Female Health Worker but still they are not registered with the

Rajasthan Nursing Council, Jaipur and in this writ petition one of the prayer is for direction to the Rajasthan Nursing Council, Jaipur to register the names of Petitioners in the Register of Registrar, Rajasthan Nursing Council - respondent No.3.

In view of above fact that petitioners are still not registered with the Rajasthan Nursing Council, Jaipur, no direction can be issued for consider their candidature for appointment in pursuance of advertisement dated 26.2.2013.

However, this writ petition can be disposed of with the direction to the respondent Council to consider and decide the application of the petitioners which are said to be pending with Council for the purpose of registration within reasonable period. Therefore, this writ petition is disposed of with the direction to the respondents No.3 to consider and decide the application of the petitioners for the purpose of registration with the Rajasthan Nursing Council, Jaipur and pass appropriate order in accordance with law within ten days from the date of receipt of certified copy of this order.
